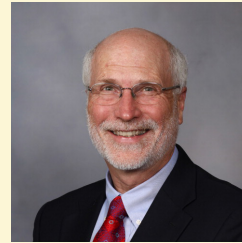

He also conducts research to improve the uptake of vaccines.

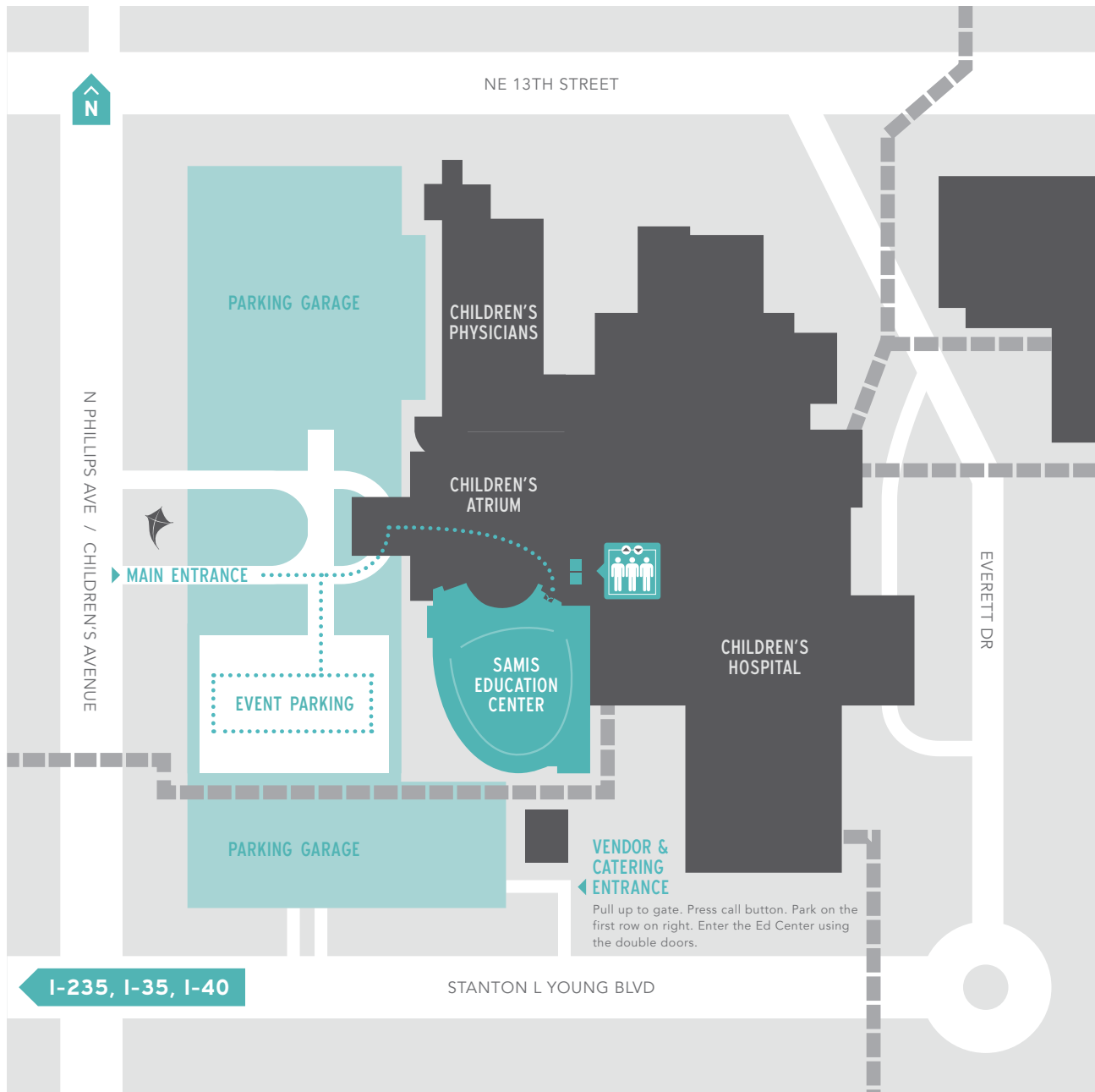
