**Professional Practice Gaps:** (1) Providers need to recognize appropriate case choices to submit to the QA Committee. (2) Providers need to know the steps for submitting cases for Quality Assessment including QI and RL. (3) Providers need to understand the opportunities for system improvements and educational opportunities brought about through QA methodologies.
