Professional Practice Gap: Pediatric patients are often faced with resistant or recurrent cancer that cannot be cured by conventional chemotherapy, radiation or surgery. Immunotherapy have become viable therapeutic option for many pediatric patients. This presentation would discuss utility of different immunotherapy in treatment of pediatric cancer.

Learning Objectives: Upon completion of this session, participants will improve their competence and performance by being able to:

1. Identify that immunotherapy is changing the treatment landscape for subset of pediatric cancer.
2. Examine the role of monoclonal antibodies and bispecific T cell engagers (BiTE) in treatment of hematologic malignancies.
3. Describe that Chimeric antigen receptor T cell (CAR-T) therapy is FDA approved for pediatric patients with relapsed acute lymphoblastic leukemia.
