Professional Practice Gap:

- ❖ Social biases and misperceptions regarding the disadvantages of short stature and the benefits of hGH-induced increases in height persist
- ❖ These biases and misperceptions continue to confound shared decision-making and informed assent about risks vs. benefits of discretionary hGH treatment
- ❖ Changes in approach to growth-aiding treatments can improve cost-consciousness, reduce risk, and minimize endorsement of heightism
