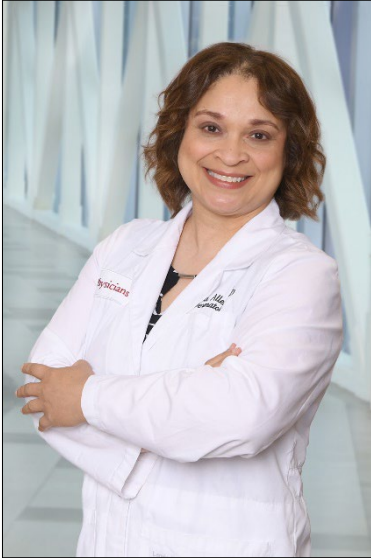
1. Prepare healthcare providers, residents, fellows, students, aestheticians, and hair care specialists to recognize the unique dermatologic features of skin of color.
